

## PROMOTER DISCLOSURE STATEMENT

The purpose of this Disclosure Statement is to inform you, the Prospective Client, that (Peak Financial Investing, LLC) (“Peak”), currently serves as an unaffiliated Promoter for Kiker Wealth Management, LLC (“Kiker”), a registered investment adviser, whose principal office is located at 788 West Church Street, Jasper, GA 30143 and is accordance with the Investment Advisers Act of 1940 and 950 CMR 12.205(8). This Statement is intended to inform you of the relationship between the Promoter and the financial advisors recommended to you by the Promoter.

Peak is introducing you, the Prospective Client, to Kiker for its investment advisory services (the “Services”), and it is important for you to receive the following.

### IMPORTANT DISCLOSURES:

- a. Peak is neither a client of Kiker nor an investor in any funds managed by Kiker.
- b. Peak is compensated to introduce Prospective Clients to Kiker’s services.
- c. Peak has a conflict of interest in recommending that you engage Kiker for its advisory services because Peak will earn a portion of the fee charged by Kiker, as described more fully below.
- d. It is our intent that this arrangement will apply to any members of your immediate family that you introduce to us and that subsequently open accounts with the third-party money manager. Any such family members will be asked to sign a disclosure statement identical to or substantively similar to this document.

### ADDITIONAL INFORMATION REGARDING PEAK’S COMPENSATION

If you, the Prospective Client, engage Kiker, Kiker will charge an advisory fee pursuant to an Investment Advisory Agreement. Pursuant to a separate Promoter Agreement between Peak and Kiker, Kiker will pay to Peak, as a referral fee, 30% of the advisory fee collected by Kiker. Kiker will not charge you any additional fees or expenses as a result of the referral fees it pays to the Peak.

### CONFLICT DISCLOSURES

It is important for you to understand that Peak has an incentive to recommend Kiker as a result of the compensation Peak will receive if you decide to engage Kiker to provide investment advisory services. Kiker will charge a fee, and Peak will receive a portion of that fee. This creates a conflict of interest that we believe is important for you to understand before engaging Kiker.

### OTHER IMPORTANT INFORMATION

Peak is not authorized to provide investment advice on behalf of Kiker or regarding Kiker’s services. Peak’s role is limited exclusively to that of a Promoter and Peak does not give, and has not given, investment-related advice on behalf of Kiker.

Peak does not have authority to accept Investment Advisory Agreements on behalf of Kiker or to collect or receive payment in its own name for any Investment Advisory Agreement. All Investment Advisory Agreements are subject to acceptance by Kiker.
